The following is the analysis of number of responses per question. Based on mean value of each questions, action and recommendations were made.

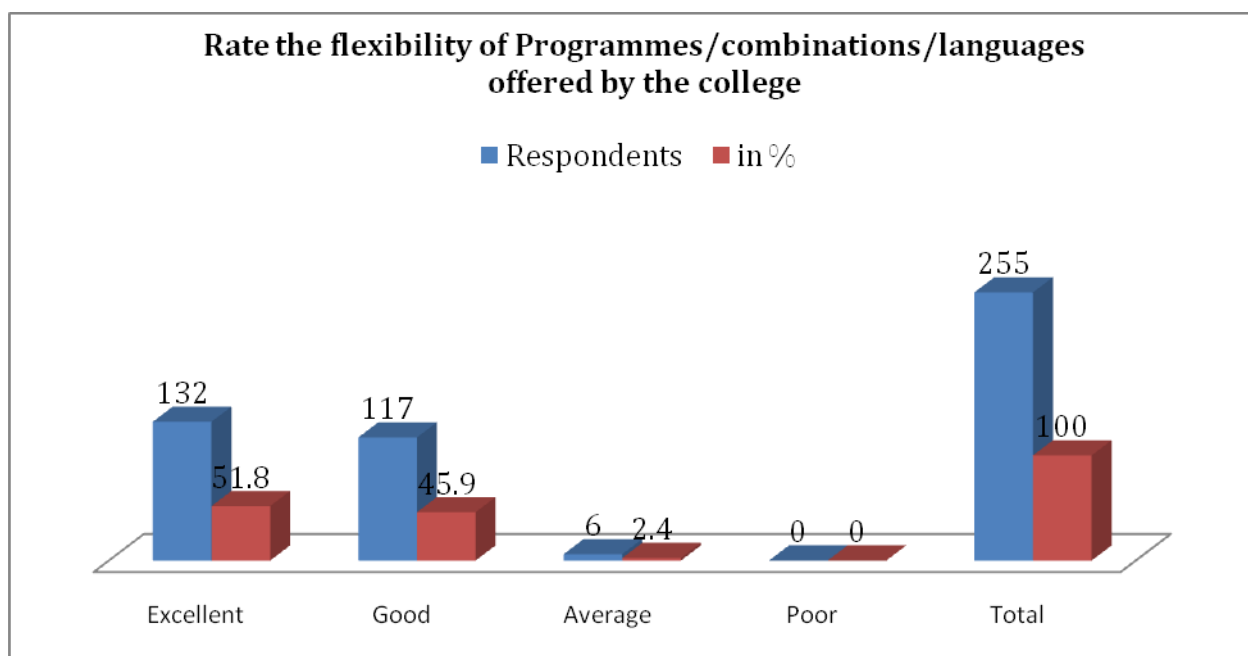
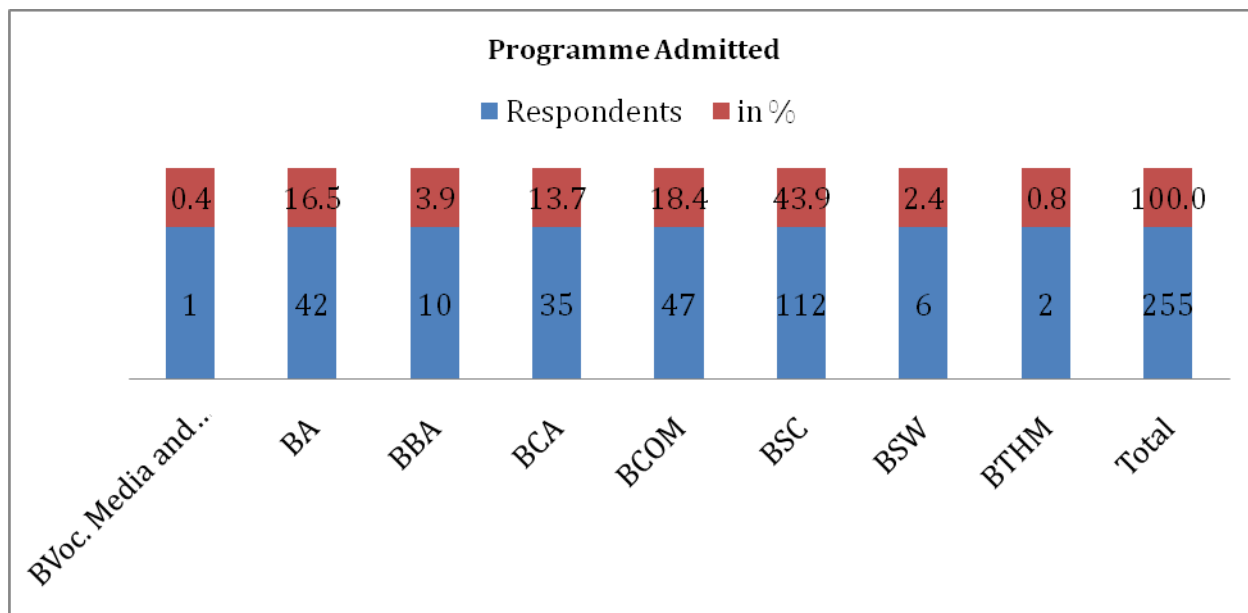
Mean score:

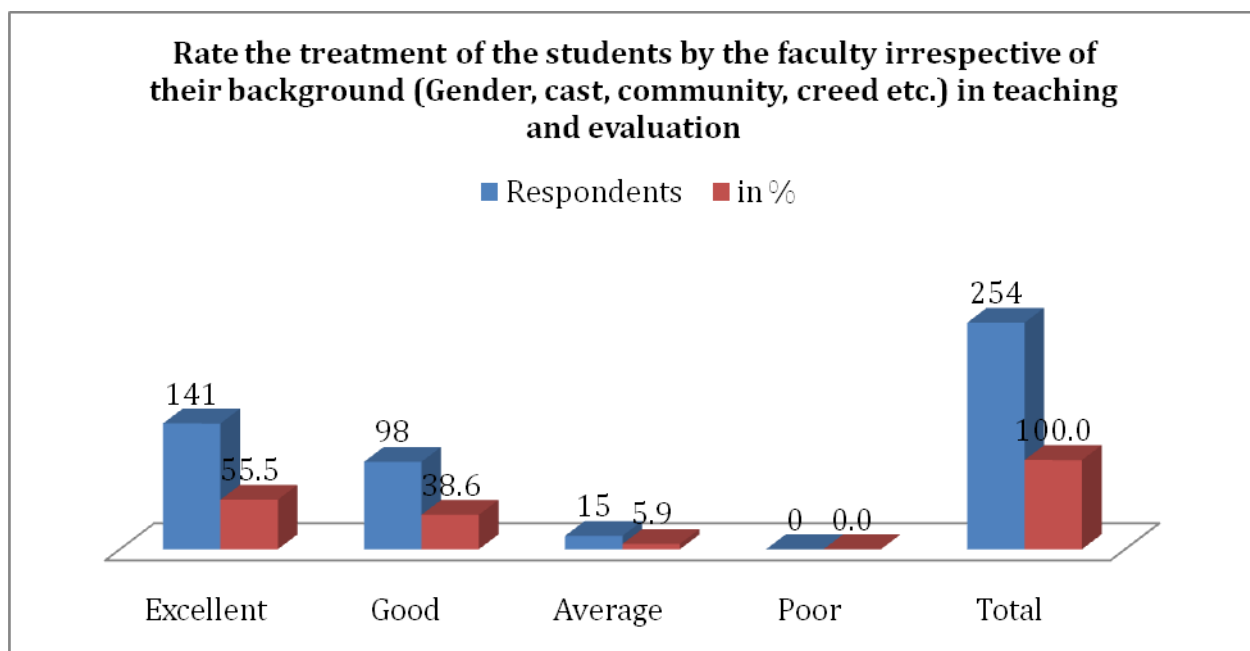
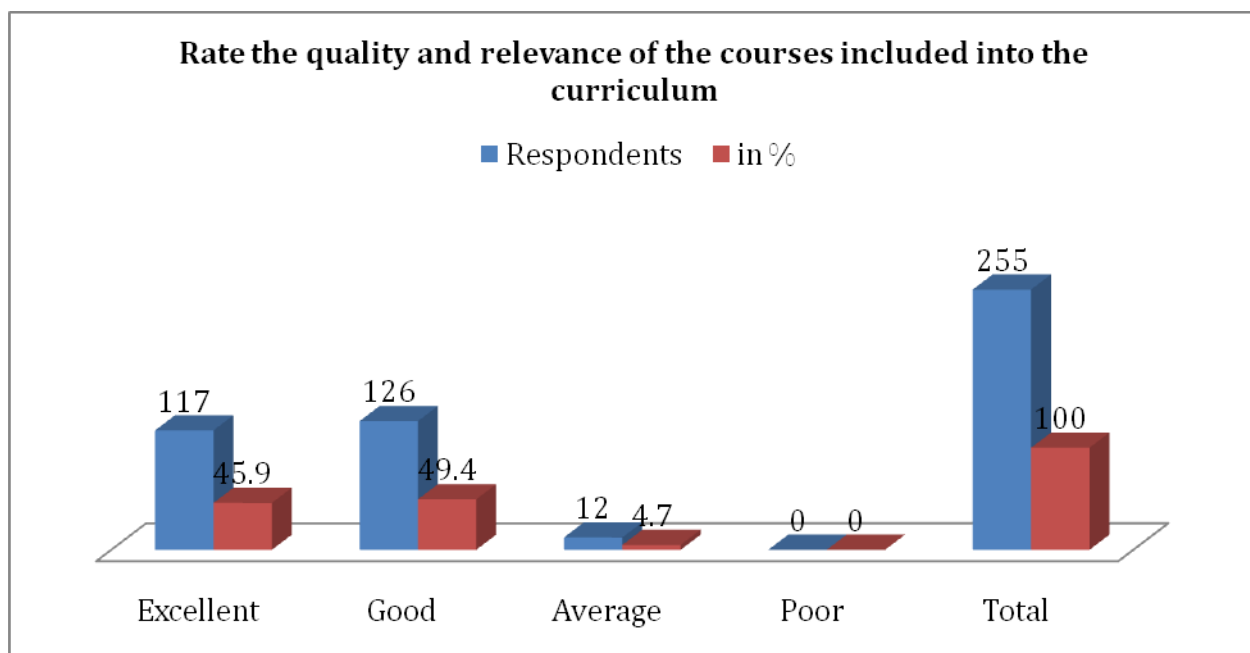

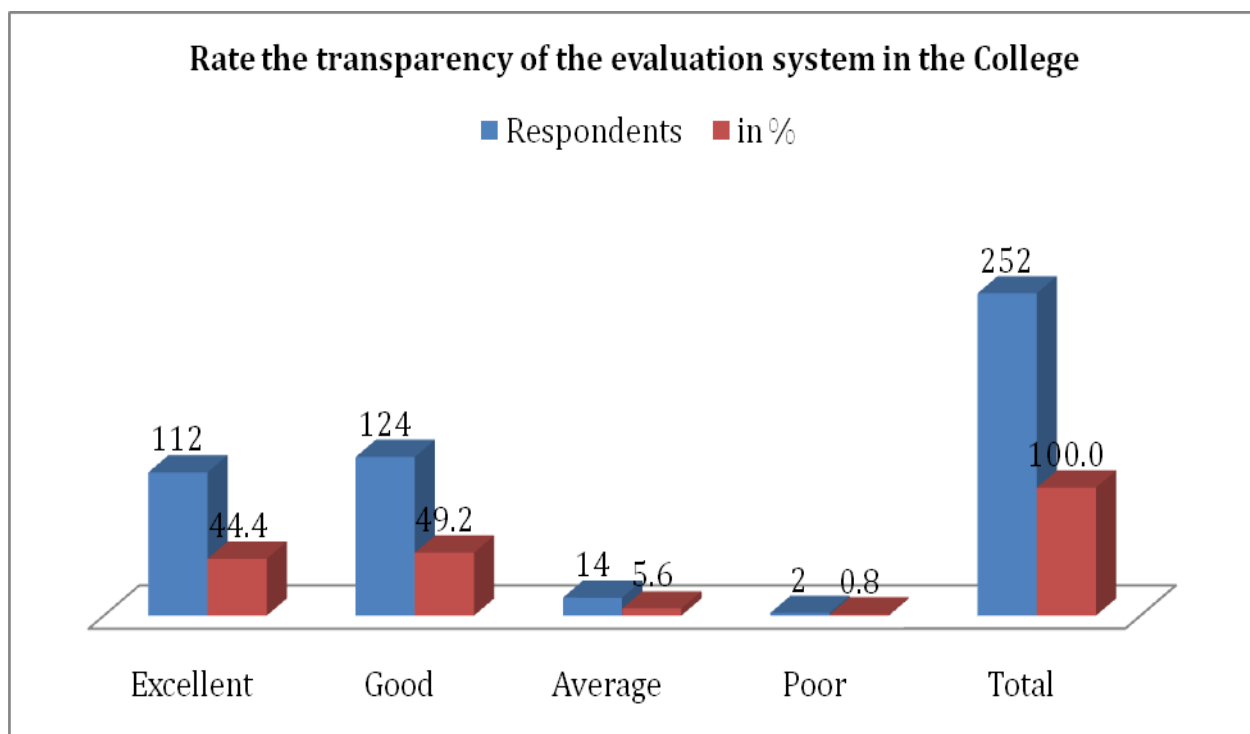
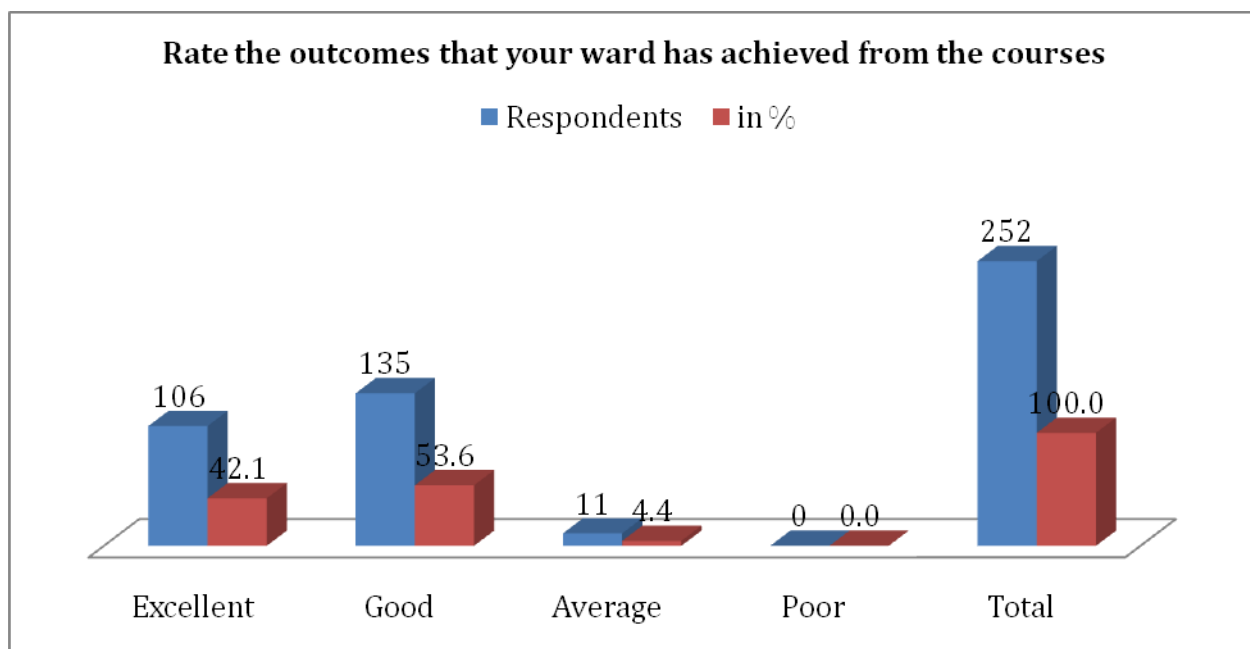
A detailed graphical representation of different components were presented here

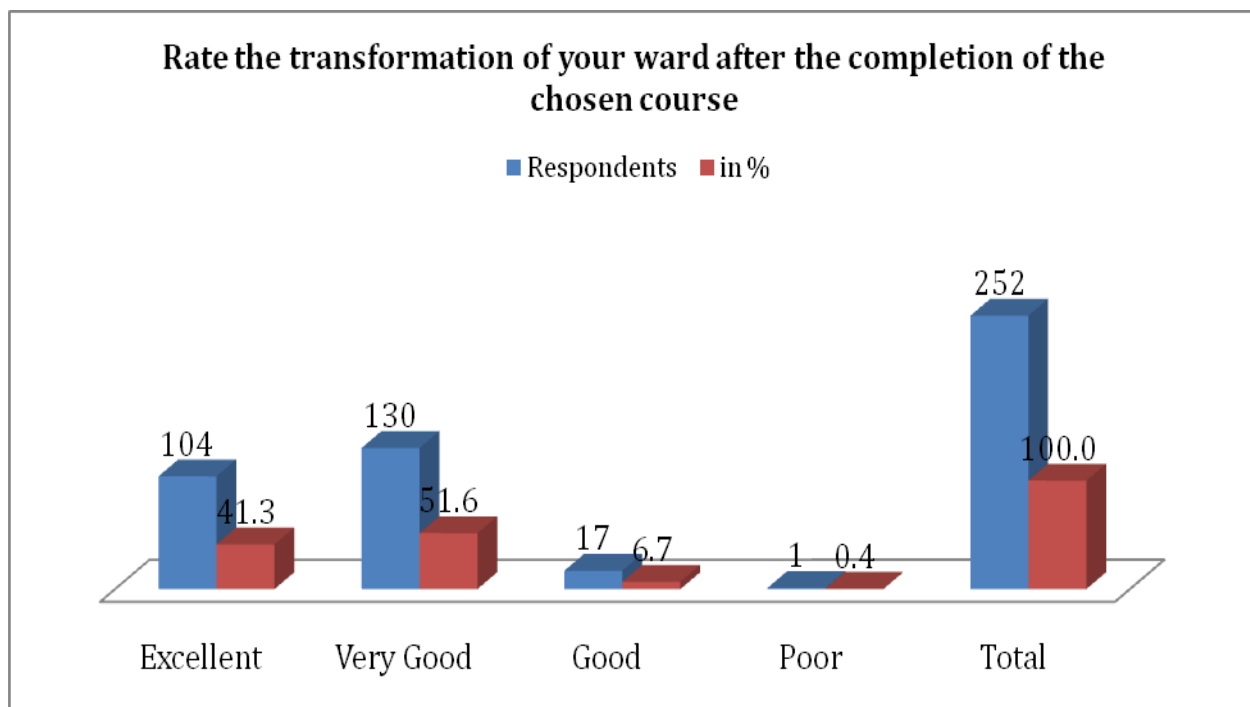












Conclusion
