The following is the analysis of number of responses per question. Based on mean value of each questions, action and recommendations were made.


Mean score:






Students response on Curriculum activities in the College

Note: Components which has >3 mean value not required any action. And it will be considered as satisfactory feedback given by Students concerning various components.












































Conclusion
