Teachers Feedback 2020

The IQAC team of the institution has collected feedback on curriculum from all stakeholders as part of quality monitoring and quality assurance practices implemented in the institution. Feedback is usually collected during the final exam or after the final exam or during convocation session. The feedback link is also available in the website and all stakeholders are encouraged to fill in the feedback form.

Here the feedback given by teachers on curriculum was presented. The data collected by using questionnaire which contains 10 components of curriculum aspects. So collected data were analyzed by using the SPSS software and the result was reviewed by the IQAC team. Remarks, action taken report, and recommendations are prepared and forwarded to the management which is in turn forwarded to relevant stakeholders.

The following is the analysis of number of responses per question. Based on mean value of each questions, action and recommendations were made.


Mean score:

The IQAC team has analyzed the overall responses and the average score per question. In order to achieve this, responses for each question was collected in a scale of 0-1, with 0 being the "NO" and 1 being "YES". The average test score was fixed to 0.60 (statistically 0.50) and analysis was done based on the test mean value. Mean value of all components were arrived at using the SPSS software and analysis was done considering test mean value as base.







Graphical Representation of Teachers Feedback on Curriculum Components





