The following is the analysis of number of responses per question based on mean value

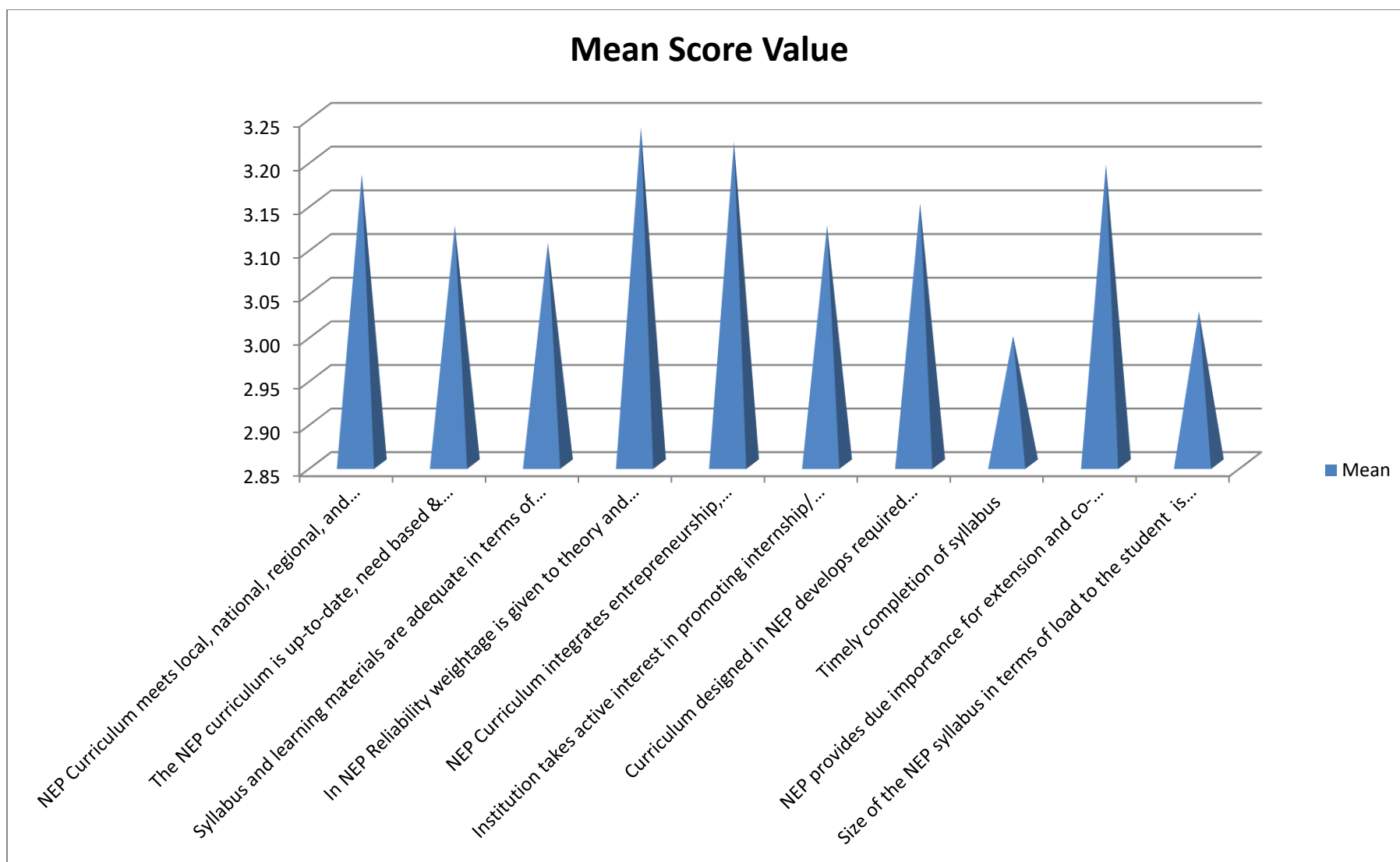
The various questions were

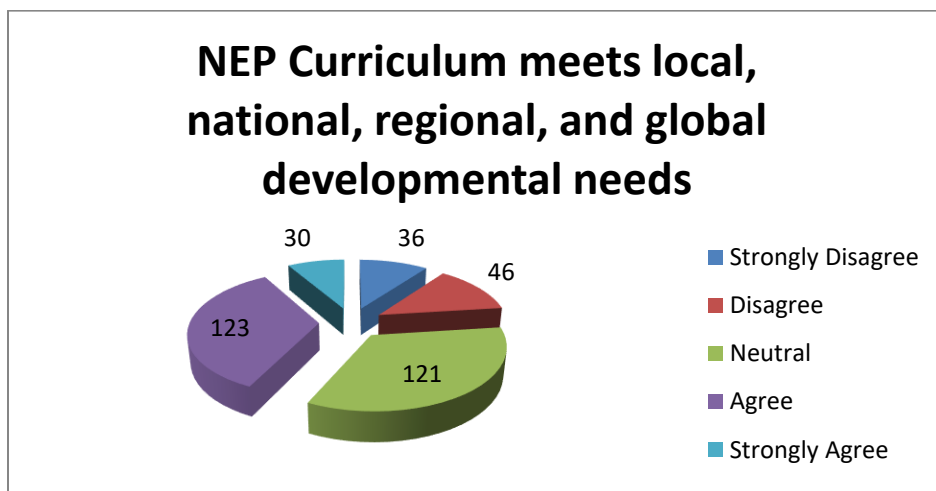

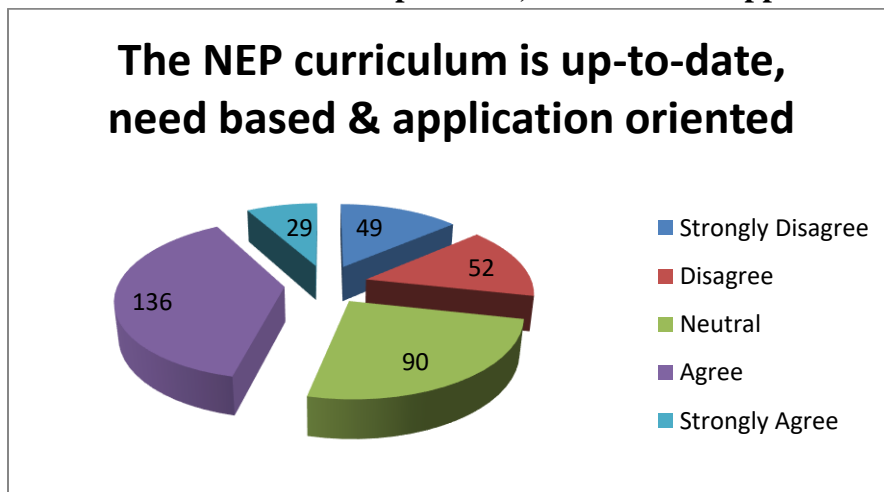

Graphical representation of feedback on curriculum:

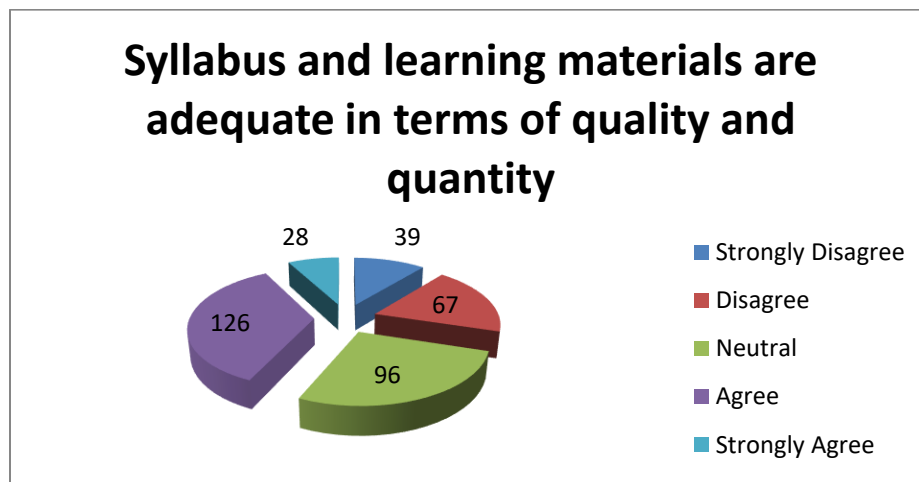
