15. Multidisciplinary / interdisciplinary

As notified by the Karnataka State Higher Educational Council and as per the regulations laid down by the University of Mysore, the institution implemented the NEP 2020 to all the streams opting the 2A framework structure. After a series of deliberations with the teachers, management the NEP 2020 was implemented 'in toto'. Accordingly the admission process was revamped. Under this, Discipline Specific Core (DSC) courses, Ability Enhancement Compulsory Courses (AECC) with a stress on two languages (L) system (L1 and L2), Skill Enhancement Courses -Value Based (SEC-VB) and Skill Enhancement Courses -Skill Based (SEC-SB) and Open Elective Courses (OE) were offered to the students. The students were given freedom to choose their language courses and Open Elective courses cutting across the stream. Many Open Elective courses were pooled in from the various departments. To make the implementation of NEP 2020 fully functional SEC courses covering dance, music, sports etc were too introduced to enhance the learning experience of the students.

16.Academic bank of credits (ABC):

As per the recommendations of the NEP 2020, the institution created the Academic Bank of credits and the institution was enrolled with the Unified Universities and Colleges Management System (UUCMS). This was done in accordance with the policy of NEP 2020 to align with the provision of introducing the multiple entries and multiple exits system and to improve the quality of education further reducing the drop off rate of the students. The students were updated regarding the credits of the courses they have opted, the credits to be earned, the entries to be made in the UUCMS website.

17.Skill development:

The Internal Quality Assurance Cell (IQAC) in collaboration with other departments has organized Faculty development programmes, students induction programmes (orientation programmes), skill development programmes, guest lectures, seminars, extensional

activities, experiential learning activities, research activities, various other curricular and co curricular activities to upscale and lift up the academic atmosphere in the institution and to improve the quality and the skills of the students, teaching faculty members. Appropriate feedbacks were collected from the various stakeholders to check the flow of the teaching and learning system through suitable feedback forms. Regular meetings were conducted to take stock of the academic atmosphere whenever required. Appropriate activities and courses from NSS, NCC, Rangers and Rovers, Cultural Committee were provided to the students under SEC programme.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

In order to promote the Ancient Indian Knowledge system, its culture under AECC, the departments of Kannada, Hindi, Malayalam, Tamil and Urdu offer core and interdisciplinary courses to students from the different states of the country. Apart from the departments of languages, departments of Economics, Commerce, Sociology, Political Science, History and Mathematics teach the fundamentals and ideas of the Indian economy, Indian management skills, the Indian social values, the Indian political administration, the rich Indian history and heritage and the Vedic mathematics.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The Postgraduate programmes of the institution were taken as a sample study by switching over form the Learning Outcomesbased Curriculum Framework (LOCF) to the Outcome Based Education (OBE). Programmes from a few Postgraduate departments were subjected to the preparation of outcomes namely Program Outcomes (PO), Course Outcomes (CO), assignment of proper weights. The teachers handling the postgraduate courses were involved in the preparation of the OBE system and were trained in understanding the concept of OBE, the mapping and the attainment calculation. It was decided to extend the same to the other PG programmes too.

20.Distance education/online education:

The institution having been just recovered from the clutches of the pandemic situation continued the trend of offering the curriculum through the blended mode as suggested by the regulators. Both online and offline classes were conducted to ensure that the delivery of the teaching learning mechanism was fruitful and error free.

Fostering Value Based Education is the vision of the institution and the institution has a wide range of courses for educational accomplishment of this vision.

Utilization certificates for grants received from UGC, duly audited by chartered accountants, are submitted to the UGC. 6.4.3 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

A detailed annual budget for expenditure is prepared by the Finance Committee before the beginning of each academic year and presented to the Governing Body which in turn allocates funds based on the priorities and significance of the projects. Financial plans are made towards infrastructure improvement such as building additional ICT-enabled class rooms, laboratories and space for other amenities. There has been a regular increase in the salaries and allowances paid to the staff over the past five years because of this financial planning. The amount from fee collection is deposited in fixed deposits till it can fetch a substantial amount of bank interest. In addition, the college generates funds by way of registration fees, sponsorship and donations during conduct of conferences, seminars and workshops. Major and minor research projects sanctioned by various funding agencies like VGST, UGC, DST to the faculty also contribute to the building up of resources. The Examination Cell led by the Controller of Examinations consists of an Assistant Controller, Chief Superintendent, and an Examination Committee. The Finance Committee with a representative from the Governing Body decides the fee structure, infrastructural needs, funds received and the expenditure incurred. Every department has a Board of Studies which meets at least once a year to revise the curriculum with the Head of Department as the Chairperson, members nominated by the affiliating University, management nominees, special invitees from industry and research institutes, and other senior staff members of the department. The Academic Council consists of the Principal as Chairperson, nominees from the affiliating University, heads of all the departments, senior teaching staff, experts from fields like industry, commerce, law, education, medicine, engineering, etc. nominated by the governing body, member secretary nominated by the Principal and distinguished academicians as special invitees

They assess the strength of the internal check and vouch the grant-in aid from the government to ensure their proper utilization. 6.4.3 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

A detailed annual budget for expenditure is prepared by the Finance Committee before the beginning of each academic year and presented to the Governing Body which in turn allocates funds based on the priorities and significance of the projects. Financial plans are made towards infrastructure improvement such as building additional ICT-enabled class rooms, laboratories and space for other amenities. There has been a regular increase in the salaries and allowances paid to the staff over the past five years because of this financial planning. The amount from fee collection is deposited in fixed deposits till it can fetch a substantial amount of bank interest. In addition, the college generates funds by way of registration fees, sponsorship and donations during conduct of conferences, seminars and workshops. Major and minor research projects sanctioned by various funding agencies like VGST, UGC, DST to the faculty also contribute to the building up of resources. Regular and substantial revenue is generated by renting out the playground, auditorium and the indoor stadium (with its in-house gym) to others, when not used by the college.
