### 15.Multidisciplinary / interdisciplinary

As per directives from the Karnataka State Higher Education Council and in accordance with the regulations set forth by the University of Mysore, the institution has adopted the NEP 2020 across all disciplines following the 2A framework structure. Following extensive consultations with faculty and management, the NEP 2020 has been fully integrated. Consequently, the admission process has been restructured, offering Discipline Specific Core (DSC) courses, Ability Enhancement Compulsory Courses (AECC) emphasizing two-language proficiency (L1 and L2), Value-Based Skill Enhancement Courses (SEC-VB), Skill-Based Skill Enhancement Courses (SEC-SB), and Open Elective Courses (OE) to students. Students are afforded the liberty to select their language and Open Elective courses spanning across disciplines. Additionally, a variety of Open Elective courses have been sourced from multiple departments. Furthermore, to enrich the educational experience, SEC courses encompassing disciplines such as dance, music, and sports have been introduced in alignment with the NEP 2020 implementation.

### 16.Academic bank of credits (ABC):

The Academic Bank of Credits (ABC) is a pivotal initiative introduced in alignment with the recommendations of the National Education Policy (NEP) 2020. In response to these directives, our institution has established the ABC system, integrating it seamlessly with the Unified Universities and Colleges Management System (UUCMS). This integration facilitates the implementation of the NEP's provision for a multiple entries and multiple exits system, aimed at enhancing the quality of education and minimizing student dropout rates. Through the ABC system, students are provided with a transparent overview of their academic progress. They receive regular updates regarding the credits associated with their chosen courses, as well as the credits they need to accumulate to meet their academic goals. These updates are facilitated through the UUCMS website, ensuring accessibility and ease of monitoring for students. By embracing the ABC system, our institution aims to empower students with greater control over their academic journey while fostering a culture of continuous learning and progression. This innovative approach not only enhances the overall educational experience but also serves as a catalyst for improving student retention rates and promoting academic excellence.

**17.Skill development:**

The Internal Quality Assurance Cell (IQAC), in collaboration with various departments, has orchestrated a spectrum of initiatives aimed at skill development within the institution. These include Faculty Development Programs, student induction sessions, skill enhancement workshops, guest lectures, seminars, extension activities, experiential learning opportunities, and research endeavours. Through these endeavours, the academic environment is enriched, fostering the growth and proficiency of both students and faculty members. A concerted effort is made to gather feedback from stakeholders to assess the efficacy of the teaching and learning processes. This feedback, collected through suitable forms, serves as a mechanism to continually refine, and enhance the educational experience. Regular meetings are convened to evaluate the prevailing academic environment and address any emerging needs or concerns. Furthermore, the institution provides a diverse array of activities and courses through bodies such as the National Service Scheme (NSS), National Cadet Corps (NCC), Rangers and Rovers, and the Cultural Committee, as part of the Student Enhancement Component (SEC) program. These initiatives aim to augment the holistic development of students, fostering not only academic excellence but also personal growth and leadership skills.

**18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

To foster the rich heritage of Ancient Indian Knowledge and culture, the institution emphasizes the integration of Indian language, culture, and online courses. Under the Ability Enhancement Compulsory Course (AECC) framework, departments including Kannada, Hindi, Malayalam, Tamil, and Urdu offer both core and interdisciplinary courses. These courses cater to students hailing from diverse regions across the country, aiming to instil a deeper understanding and appreciation of Indian traditions. Beyond language departments, disciplines such as Economics, Commerce, Sociology, Political Science, History, and Mathematics also play a crucial role. They impart essential concepts encompassing the Indian economy, management principles rooted in Indian ethos, societal values intrinsic to Indian culture, nuances of Indian political governance, and the rich tapestry of Indian history and heritage. Additionally, Vedic mathematics finds its place within the curriculum, showcasing ancient mathematical techniques. By incorporating elements of the Indian Knowledge system across various disciplines and utilizing online platforms, the institution ensures a comprehensive and accessible approach to learning. This holistic integration not only enriches students' academic journey but also

promotes a deeper connection with India's cultural roots and intellectual heritage.

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

The institution has shifted its focus to Outcome-Based Education (OBE), particularly within its Postgraduate programs. This transition involved moving from the Learning Outcomes based Curriculum Framework (LOCF) to a more comprehensive OBE approach. Several Postgraduate departments served as pilot studies for this transition, where Program Outcomes (PO) and Course Outcomes (CO) were defined and weighted accordingly. Faculty members responsible for teaching Postgraduate courses actively participated in the development of the OBE system. They underwent training to grasp the concept of OBE, understand outcome mapping, and calculate attainment levels. This initiative aimed to align teaching and assessment practices more closely with desired educational outcomes. Following the successful implementation within select Postgraduate programs, the institution has decided to extend the OBE approach to other Postgraduate programs as well. This strategic shift towards OBE reflects a commitment to ensuring that education is not solely focused on content delivery but also on the measurable outcomes achieved by students. It emphasizes the importance of preparing students with the knowledge, skills, and competencies required for success in their chosen fields.

#### **20.Distance education/online education:**

In the wake of the recent pandemic, the institution had embraced a blended approach to education, combining both online and offline modalities to deliver its curriculum effectively. This strategic decision, still continues in line with recommendations from regulatory bodies, ensures the continuity of the teaching-learning process while navigating through challenging circumstances. By offering a mix of online and offline classes, the institution aims to provide a seamless educational experience that is both productive and devoid of errors. Central to the institution's vision is the cultivation of Value-Based Education. To fulfil this vision, a diverse array of courses is offered, catering to the educational aspirations of students across various domains. These courses are designed not only to impart academic knowledge but also to instil values and ethical principles in students, preparing them to become responsible members of society. Moving forward, the institution remains committed to leveraging distance education and online learning methodologies to adapt to evolving educational landscapes. By harnessing the potential of technology and embracing innovative pedagogical approaches, the institution endeavours to uphold its



mission of providing quality education that is accessible, inclusive, and aligned with contemporary needs.

The adoption of advanced software for computational methods is encouraged across relevant disciplines, enriching the educational experience. ICT components are seamlessly integrated into the curriculum, incorporating both free and commercial software for computational analysis and simulation purposes. Additionally, the college website hosts dedicated software such as QnSmart, functioning as a Learning Management System (LMS). These platforms facilitate the tracking of students' learning progress through online quizzes, assignment submissions, and other interactive features. Access to digital libraries and databases further supports the teaching-learning process.

These outcomes are then articulated clearly and comprehensively, reflecting the course's objectives and the broader educational goals of the institution. To communicate these COs effectively, various channels are utilized. Firstly, teachers receive detailed documentation outlining the COs, often accompanied by instructional materials and assessment guidelines. Additionally, faculty meetings, workshops, or training sessions may be conducted to ensure a thorough understanding of the COs among teaching staff. For students, COs are typically integrated into the course curriculum, providing a roadmap of learning expectations. They are also incorporated into classroom discussions to enhance student awareness. Furthermore, digital platforms like institutional websites serve as repositories for CO-related information, facilitating easy access for students. Regular feedback mechanisms, including assessments and evaluations, allow for ongoing monitoring of student progress toward achieving the COs, ensuring alignment with the educational objectives.

The CO attainment is assessed by both direct and indirect methods.

In the direct method of evaluating Course Outcome (CO) attainment, rubrics stand out as the primary tool. These CO assessment rubrics meticulously outline the criteria for appraising students' performance. The assessment of a Course Outcome hinges on students' performance in both formative or Continuous Comprehensive Assessment (CCA) and summative assessments conducted throughout the course.

At the postgraduate (PG) level, the CCA component contributes 30% to the overall CO attainment, while the summative assessment carries a weightage of 70%. In accordance with the National Education Policy (NEP) scheme, at the undergraduate (UG) level, the distribution is 60:40, respectively. The direct method's 80% weightage is factored in when calculating the attainment. Conversely, in the indirect method, students' feedback on course outcome attainment is gathered after each semester. Additionally, a program exit survey is conducted upon completion of the program, along with surveys for alumni and employers. The indirect method carries a 20% weightage when computing attainment. Regarding CO Assessment Tools, the college establishes a variety of assessment instruments and determines their frequency at the start of the academic year.

Principal then presents the proposal before the college management, who takes the final decision on priority basis. Principal assigns the work to the concerned personnel. Regular maintenance work in the college takes place immediately, while longer projects are executed during vacation.
