Resolutions:-

- 1) After detailed discussion, the committee members approved the syllabus for I & II Semester B.Sc Environmental Science as per the guidelines of modified SEP as recommended by the govt of Karnataka and the same is annexed here with. The approved syllabus will come into effect from the current academic year 2024-25.
- 2) The committee approved the scheme of Examination & question paper pattern (Theory & practical) for the I & II semester Examination in Environmental Science which is annexed here with.
- 3) The scheme of valuation for theory C1 and C2 are internal test to be conducted during 8th and 15th week respectively of the Semester. The student is evaluated for 10 marks in each C1 and C2 and C3 is the semester end Examination conducted for 80 marks and is of 03 hrs duration.
The scheme of valuation for

practical C₁ is an internal test to be conducted during 8th week and C₂ is the evaluation of the assignment or tour report of field visit submitted by students during 15th week of the semester. The student is evaluated for 05 marks in each C₁ & C₂ and C₃ is an semester end examination conducted for 40 marks and is of 03 hours duration. The students have to produce practical record duly signed by the batch incharge supervisor and counter signed by the Head of the department at the time of practical examination without which the student will not be allowed to appear for the practical examination.

4) The committee members strongly recommended Chemistry, Biotechnology, Environmental Science [CBEN] and Chemistry, food science and Environmental Science [CFEN] course along with existing combination.

5) The committee approved the panel of Examiners for the academic year 2024-25 annexed here.


6) The committee recommended that the students of all semester should take




part on educational tour / field visit / industrial visit in all semester in addition to assigned for skill development.




