The Principal, Dr. Ravi J D Saldanha introduced and welcomed the members. The meeting commenced with the prayer rendered by Rev. Msgr. Alfred John Mendonca, Vicar General of Mysore Diocese and Vice President of MDES. The Principal gave a brief presentation on the major milestones of the institution, various academic, co-curricular, and extra-curricular activities held during the academic year 2022-23

The following agenda was taken up for discussion and approval.

## Agenda-1 Approval of the Minutes of the 11th Governing Body held on 09.05.2022

The Principal placed the minutes of the 11<sup>th</sup> Governing Body held on 09.05.2022which was circulated earlier among the members and sought its approval.

Decision: Approved.

# Agenda-2 Review of the functioning of Autonomy for the academic year 2021-22 and Action Plan for 2022-23.

The Principal informed the members that the college has submitted the proposal for the extension of autonomy for the third cycle through the University of Mysore to the UGC in October 2022 and is waiting for the response. He briefed the progress made by the college both academically and financially and the challenges faced in the implementation of the curriculum framed by the Karnataka State Higher Education Council (KSHEC) and forwarded by the affiliated university in view of the implementation of NEP 2020 by the state government thereby suppressing the academic autonomy of the College. Mr. Ronald Prakash Cutinha, Vice Principal of Administration expressed the challenges faced by the institution due to the central government policies to offer more free online programmes as a part of the UG &PG programme curriculum, collecting of high affiliation fees by the affiliated university, and the task of raising funds to retain the competent faculty. He wished that the UGC and other funding agencies would continue to provide more financial support, especially in the light of NEP 2020. He also informed that the college is focusing on increasing the diversity of programmes to improve student strength. Prof. K. Chidananda Gowda opined that the college should aspire to become a World Class University.

a) The Principal briefed the members on the amendments made to the existing "NEP Model Programme Structure" for the Undergraduate Programmes in Arts, Science, Commerce, and Management suggested by the Karnataka State Higher Education Council (KSHEC) in its circulars dated: 07/11/2022) and the University of Mysore circular dated: 09/12/2022.

b) Introducing the existing I& II semester NEP curriculum with modification to the UG programmes from the AY 2022-23 onwards.

The Principal informed the members that the curriculum framed by the Karnataka State Higher Education Council (KSHEC) for semesters I and II is revised to the extent of 20 percent by the concerned UG departments of the College and approved in their respective BOSmeetingsfortheUGprogrammesandisratifiedbytheAcademicCouncilinits Meeting held on6<sup>th</sup>January2023.

c) Introducing the NEP curriculum framed by KSHEC and forwarded by the University of Mysore to the III and IV semesters from the AY 2022-23

Decision: Approved

d) Starting of M.Sc.in Criminology & Forensic Science Programme approved by the University of Mysore from the Academic Year 2022-23 with the curriculum framed by the University of Mysore.

The Principal informed the council that the college has introduced the M.Sc. in Criminology & Forensic Science Programme from the AY 2022-23 with the approval of the University of Mysore with a sanctioned strength of 30 students. The programme has received a good response from the student and 22 students have taken the admission. Prof. Sanjeev Kumar Sharma mentioned that Officers in Defense Forces can take up this programmeandothersimilarprogrammeswhichareinhighdemandinmanypartsofthe Country may be introduced.

e) Changing the nomenclature of the existing MA Holistic Spirituality Programme into MA Philosophy and Holistic Spirituality Programme.

The Principal informed the members that for the last few years the college was admitting students to MA Holistic Spirituality. However, the programme did not get any admissions for the current AY2022-23. Tomaketheprogramme more attractive and meaningful, at the requestofthecollegetheUniversityofMysorehaspermittedtochangeitsnametoMA Philosophy and Holistic Spirituality.

f) Reintroducing the M.Sc. in Psychology Programme which was temporarily kept in abeyance due to the non-admission of the required number of students.

The Principal mentioned that the M.Sc. in Psychology Programme was temporarily kept in

abeyance for not getting the required number of student admissions. As some inquiries for the programme were received the college is reintroducing the M.Sc. in Psychology Programme from the A-Y 2022-23.

g) Starting of the following PG Programmes from the Academic Year 2023-24 for which the approval is obtained from the University of Mysore

#### 1.MCA 2.MBA

The Principal informed the members that on the advice of the management, the college is starting MCA & MBA programmes from the AY 2023-24 and waiting for a NOC from the University to process the application and submit it to AICTE.

Taking up the discussion, the Principal and the PG Director mentioned that there is a lackofclarityregardingNEPguidelinesforthefourth-yearHonorsundergraduatecourses

.Prof. Laxman Ayyapp Kulagod, the Regional Joint Director for Collegiate Education, Mysore informed the council that the honors course would be offered for the colleges having the required infrastructure and qualified faculty. A limited number of students will be permitted to take admissions and the honors programmes would be offered. Prof. K. Chidananda Gowda informed that the four-year honors degree would provide opportunities to students aspiring to go abroad for higher studies.

Mr. M. Nagaraj Urs informed the members that KSHEC in its circular dated 30/03/2023 provides two options (Honours degree with research or without research) for the students who complete the three years UG programme under NEP,

**Option-1:** The students with a CGPA above 7.5 are eligible to opt for an honors programme with research.

**Option-2:** The students with a CGPA less than 7.5 are eligible to opt for an honor sprogramme without research.

Mr.Ronald Prakash Cutinha expressed the need to start new programmes like a Bachelor in Education in the light of NEP. He added that apart from the subjects mentioned in the said agenda, from time to time more departments need to be equipped with resources to take up the four years degree programmes. Prof. Laxman Ayyapp Kulagod suggested that the college authorities should think of starting Bachelors in Aviation Management.
