15.Multidisciplinary / interdisciplinary

As notified by the Karnataka State Higher Educational Council and as per the regulations laid down by the University of Mysore, the institution implemented the NEP 2020 to all the streams opting the 2A framework structure. After a series of deliberations with the teachers, management the NEP 2020 was implemented 'in toto'. Accordingly, the admission process was revamped. Under this, Discipline Specific Core (DSC) courses, Ability Enhancement Compulsory Courses (AECC) with a stress on two languages (L) system (L1 and L2), Skill Enhancement Courses -Value Based (SEC-VB) and Skill Enhancement Courses -Skill Based (SEC-SB) and Open Elective Courses (OE) were offered to the students. The students were given freedom to choose their language courses and Open Elective courses, cutting across the stream. Many Open Elective courses were pooled in from the various departments. To make the implementation of NEP 2020 fully functional SEC courses covering dance, music, sports etc were too introduced to enhance the learning experience of the students.

16.Academic bank of credits (ABC):

As per the recommendations of the NEP 2020, the institution facilitated the students to register under Academic Bank of Credits, and the institution was enrolled with the Unified Universities and Colleges Management System (UUCMS) portal of the state government of Karnataka. This was done in accordance with the policy of NEP 2020 to align with the provision of introducing the multiple entries and multiple exits system and to improve the quality of education further reducing the drop off rate of the students. The students were updated regarding the credits of the courses they have opted for, the credits to be earned, and the entries to be made in the

17.Skill development:

The Internal Quality Assurance Cell (IQAC) in collaboration with other departments has organized Faculty development programmes, students induction programmes (orientation programmes), skill development programmes, guest lectures, seminars, extensional activities, experiential learning activities, research activities, various other curricular and co-curricular activities, sports activity to upscale and lift up the holistic academic atmosphere in the institution and to improve the quality and the skills of the students, teaching faculty members. Appropriate feedbackwas collected from the various stakeholders to check the flow of the teaching and learning system through suitable feedback forms. Regular meetings were conducted to take stock of the academic atmosphere whenever required. Appropriate activities and courses from NSS, NCC, Rangers and Rovers, Cultural Committee were provided to the students under SEC programme.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

To promote the Ancient Indian Knowledge system, its culture under AECC, the departments of Kannada, Hindi, Malayalam, Tamil and Urdu offer core and interdisciplinary courses to students from the different states of the country. Apart from the departments of languages, departments of Economics, Commerce, Sociology, Political Science, History and Mathematics teach the fundamentals and ideas of the Indian economy, Indian management skills, the Indian social values, the Indian political administration, the rich Indian history and heritage and the Vedic mathematics. Value Based Courses (VBC) like yoga, music, dance were offered to the students as an integral part of the Autonomous curriculum aligning with NQSF/NCrF.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The Postgraduate programmes offered under CBCS with the Learning Outcome based Curriculum Framework (LOCF) were subjected to assess the learning levels of the students through the Outcome Based Education (OBE). Postgraduate departments were encouraged in the preparation of outcomes namely Program Outcomes (PO), Course Outcomes (CO), Programme Specific Outcomes (PSO) and assignment of proper weights. The faculty handling the postgraduate courses were involved in the preparation of the OBE system and were trained in understanding the concept of OBE, the mapping, and the attainment calculation. It was decided to extend the same to the other UG programmes too.

20.Distance education/online education:

The institution continued the trend of offering the curriculum through the blended mode as suggested by the regulators. Both online and offline classes were conducted to ensure that the delivery of the teaching learning mechanism was fruitful and error free. The institution has integrated SWAYAM (Study Webs of Active Learning for Young Aspiring Minds) and MOOCs (Massive Open Online Courses) into its academic ecosystem. Faculty members have been encouraged to develop and participate in MOOCs, enhancing their teaching skills and expanding course offerings. Students have access to a wide range of SWAYAM and MOOC courses, enabling them to supplement their classroom learning and develop new skills. The institution promotes these online resources through its website, social media, and student orientation programmes. Fostering Value Based Education is the vision of the institution, and the institution has a wide range of courses for educational accomplishment of this vision.

The institution is loaded up with extensive facilities for cultural activities like yoga, and indoor and outdoor sports, including a gymnasium, yoga center, and auditorium. Established practices and procedures ensure the effective maintenance and utilization of these physical, academic, and support facilities. A dedicated team, consisting of the Physical Education Director, Sports Secretary, and maintenance staff, oversees the management of sports facilities, such as the indoor stadium, multi-gym, and outdoor stadium. Regular maintenance includes watering and levelling the grounds, de-weeding, and guarding the track, especially on event days.

Yoga is integrated into the curriculum and is conducted regularly in the indoor stadium, while larger events with significant participation take place on the sports ground. Cultural competitions and other college activities are held in the college auditorium or indoor stadium. The multi-gym is maintained by a professional gym instructor including treadmills, cardiovascular machines, fixed machines, free weights, and a multigym. Both students and faculty have access to these facilities, and beginners receive training in equipment handling from an expert instructor. The Department of Physical Education supervises the overall operation of the gymnasium.

The college has established exhaustive systems and procedures for the maintenance and utilization of its physical, academic, and support facilities, including classrooms, laboratories, libraries, sports complexes, and computer labs. A team of experienced and qualified staff look for the regular maintenance of these facilities. In the event of any issues, Heads of Departments (HODs) and other stakeholders who identify problems can submit a request to the Principal. The Principal then presents the proposal to the college management, which makes a final decision based on priority. Upon approval, the Principal assigns the tasks to the appropriate staff members.

Regular maintenance is carried out on time, while larger projects are scheduled during vacation periods. The Physical Education Department is responsible for the upkeep of sports facilities and equipment, and an annual stock check is performed. Periodic maintenance activities, such as staving offold books, binding, pest control, and other necessary measures, are also undertaken.

Three daily wage personnel are tasked with maintaining the cleanliness and upkeep of the physical infrastructure.

Infrastructure upgrades and equipment improvements are handled on a contract basis. Maintenance of electrical equipment is carried out voluntarily by skilled non-teaching staff appointed by the college. For major repairs, external professionals are engaged. The coordinated efforts of the Management, Principal, and college staff through various academic and administrative committees have led to the continuous enhancement and strengthening of infrastructure, supporting excellence in academics, research, and co-curricular activities.

The institution is loaded up with extensive facilities for cultural activities like yoga, and indoor and outdoor sports, including a gymnasium, yoga center, and auditorium. Established practices and procedures ensure the effective maintenance and utilization of these physical, academic, and support facilities. A dedicated team, consisting of the Physical Education Director, Sports Secretary, and maintenance staff, oversees the management of sports facilities, such as the indoor stadium, multi-gym, and outdoor stadium. Regular maintenance includes watering and levelling the grounds, de-weeding, and guarding the track, especially on event days. Yoga is integrated into the curriculum and is conducted regularly in the indoor stadium, while larger events with significant participation take place on the sports ground. Cultural competitions and other college activities are held in the college auditorium or indoor stadium. The multi-gym is maintained by a professional gym instructor including treadmills, cardiovascular machines, fixed machines, free weights, and a multigym. Both students and faculty have access to these facilities, and beginners receive training in equipment handling from an expert instructor. The Department of Physical Education supervises the overall operation of the gymnasium.

The college has established exhaustive systems and procedures for the maintenance and utilization of its physical, academic, and support facilities, including classrooms, laboratories, libraries, sports complexes, and computer labs. A team of experienced and qualified staff look for the regular maintenance of these facilities. In the event of any issues, Heads of Departments (HODs) and other stakeholders who identify problems can submit a request to the Principal. The Principal then presents the proposal to the college management, which makes a final decision based on priority. Upon approval, the Principal assigns the tasks to the appropriate staff members.

Regular maintenance is carried out on time, while larger projects are scheduled during vacation periods. The Physical Education Department is responsible for the upkeep of sports facilities and equipment, and an annual stock check is performed. Periodic maintenance activities, such as staving offold books, binding, pest control, and other necessary measures, are also undertaken.

Three daily wage personnel are tasked with maintaining the cleanliness and upkeep of the physical infrastructure. Infrastructure upgrades and equipment improvements are handled on a contract basis. Maintenance of electrical equipment is carried out voluntarily by skilled non-teaching staff appointed by the college. For major repairs, external professionals are engaged. The coordinated efforts of the Management, Principal, and college staff through various academic and administrative committees have led to the continuous enhancement and strengthening of infrastructure, supporting excellence in academics, research, and co-curricular activities.

A Workshop on Outcome-Based Education was held on August 24, 2023, to familiarize faculty with OBE frameworks and tools for mapping and calculating educational outcomes. Participants gained insights into the integration of Bloom's Taxonomy and the preparation of analytics for NAAC accreditation.

Furthermore, the Fulbright Research Fellowships Lecture in December 2023 inspired faculty to explore international research opportunities, while the State-Level Workshop on Data Analysis Using SPSS on December 14-15, 2023, provided hands-on training in statistical methods and SPSS software for research.

On March 16, 2024, the college hosted an Awareness Program on Learning Resources, focusing on databases like EBSCO and J-Gate. This session empowered students and faculty with the tools to navigate digital resources for research, emphasizing their role in business decision-making.

On May 29, 2024, a Capacity Building Programme on DrillBit -Plagiarism Checker and Professional Ethics was conducted to educate faculty and students on academic integrity and the use of plagiarism-checking tools. The campus is equipped with strategically placed dustbins in key areas, including academic buildings, the canteen, administrative offices, and classrooms.
