

The Monitoring Committee visit was conducted with the following objectives.

- To review the effective implementation of autonomous status.
- To assess academic governance and administrative efficiency.
- To evaluate curriculum design, assessment systems, and learning outcomes.
- To verify statutory compliance with UGC Regulations, 2023.
- To examine quality assurance mechanisms
- To identify best practices, strengths, challenges, and scope for improvement
- To provide constructive recommendations for future institutional development

PART D: INSTITUTIONAL PROFILE AND GOVERNANCE

St. Philomena's College (Autonomous), Mysuru, established in 1946 and managed by the Mysore Diocesan Educational Society, is a premier higher education institution affiliated to the University of Mysore. The institution is recognized under Sections 2(f) and 12(B) of the UGC Act, 1956. The college operates with a clear vision and mission guided by its motto "Caritas in Scientia – Service through Knowledge", emphasizing holistic development, ethical values, social responsibility, and academic excellence.

2. Governance Structure and Leadership

The institution has established a robust governance framework in accordance with UGC Regulations, 2023, comprising:

- Finance Committee
- Boards of Studies
- Controller of Examinations

Statutory committees such as IQAC, Internal Complaints Committee, Anti-Ragging Committee, Student Grievance Redressal Committee, Equal Opportunity Cell, and committees for the inclusion of persons with disabilities are functioning effectively.

The Monitoring Committee held detailed interactions with the institutional leadership, including the Rector, Rev. Dr. Lourdu Prasad Joseph, Principal, and Vice-Principal. Governance processes were found to be transparent, participative, digitized, and aligned with statutory norms.

- Curriculum revisions are periodic and responsive to industry needs, societal relevance, and national education priorities.


PART F: ADMISSION PROCESS AND STUDENT PROFILE

The Controller of Examinations provided detailed clarifications. Results are generally declared within 10 days, ensuring transparency and efficiency.

3. Academic Performance

During 2024–25, several UG and PG programmes recorded pass percentages exceeding 80%, indicating strong academic outcomes.

2. Extension Activities




The institution provides scholarships, counselling, mentoring, and career guidance. The Placement Cell organizes recruitment drives and training programmes.

The Committee inspected the Central Library, laboratories, MBA and MCA departments, and ICT infrastructure. Facilities were found to be adequate and supportive of teaching, learning, and research.

PART M: STUDENT FEEDBACK AND INTERACTION

A closed-door interaction with 40 students revealed satisfaction with academic quality and faculty support. Suggestions included improving Wi-Fi facilities, organizing industrial visits for B.Com students, and enhancing inter-collegiate interactions.

PART N: JOURNALISM AND MASS COMMUNICATION STUDIO FACILITIES

The Committee appreciated the well-equipped studio supporting experiential learning and practical training.

Recommendations:

- Initiate consultancy and professional services in media production
- Conduct external training and outreach programmes
- Strengthen industry linkages and revenue generation

The Committee advised regular publication of performance reports, statutory disclosures, and academic information on the institutional website.




